Alternatively, you may choose to receive the Corporate Communications in printed form and select to receive either English only or Chinese only or both languages as set out under options (b) to (d) in the Reply Form.

We request that you complete and return the Reply Form with enclosed pre-paid addressed envelope, indicating your choice of the means of receipt and/or choice of language(s) of Corporate Communications to the Company's Hong Kong Share Registrar, Tricor Investor Services Limited at 26/F Tesbury Centre, 28 Queen's Road East, Hong Kong on or before 28 September 2009.

If you do not complete the Reply Form and return it to the Company's Hong Kong Share Registrar at the address indicated above by 28 September 2009, you will be DEEMED to have agreed to access Corporate Communications via the Company Website and a printed copy of the Notification will be sent to you by post when such Corporate Communication(s) is/are posted on the Company Website.

If you choose to receive the Corporate Communications in printed form, the Company will send the selected language(s) of the Corporate Communications to you unless and until you notify the Company that you wish to receive the Corporate Communications in the other (or both) language(s) or to change your choice of the means of receipt of Corporate Communications. You are entitled to request for Corporate Communications in the other (or both) language(s) and/or to change your choice of language(s) and/or the means of receipt of Corporate Communications at any time by notice in writing to the Company's Hong Kong Share Registrar at the above address or by sending an email to the Company's Hong Kong Share Registrar at solomon2878-ecom@hk.tricorglobal.com.
